PROCEDURE

TIME LIMIT

You must file your Factum, your List of Exhibits and your exhibits within 30 days of receiving the Plaintiff's Factum.

FILING AT THE COURT OFFICE

You must file **5 copies**, **plus 1 additional copy for each of the other parties to the case** (e.g. if the Plaintiff is the Commission des droits de la personne et des droits de la jeunesse acting on behalf of 2 victims, you must file 8 copies) of your *Factum*, your *List of Exhibits* and your exhibits at the office of the Court of Québec of the judicial district where the *Application to Institute Proceedings* was filed.

JUDICIAL FEES

There are no judicial fees to file your Factum and your List of Exhibits.

FILE NUMBER

The file number appears on the *Application to Institute Proceedings* that was served to you by court bailiff. This number must appear on all the documents or proceedings that you file.

NOTIFICATION

You do not have to send your *Factum*, your *List of Exhibits* and your exhibits to the other parties. The Tribunal will take care of this matter.
